COUNCIL TAX DISCOUNT APPLICATION FORM

Please complete this form if you wish to claim a Council Tax reduction for either yourself or another member of your household.

To qualify for this exemption the carer must meet **ALL** of the following conditions:

- (a) the carer must provide care to a person who receives one of the following benefits;
 - (i) higher rate attendance allowance,
 - (ii) the highest rate of the care component of disability living allowance,
 - (iii) the highest rate of disablement pension,
 - (iv) an increase in a constant attendance allowance,
(proof of the above is required)
- (b) live in the same house as the person to whom he/she is giving care,
- (c) provide care for at least 35 hours a week,
- (d) not be a disqualified relative (i.e. spouse, partner, or parent of the other, who is a child below the age of 18 years).
